Níl cead aon ghléas stórála, eochar USB, CD nó DVD a úsáid gan cead an mhúinteora.</li> <li>6. Níl cead féachaint ar aon rud mídhleathach a d'fhéadfadh damáiste a dhéanamh do chlú na scoile.</li> <li>7. Níl cead fón póca ag daltaí ar scoil.</li> <li>8. Má bhristear aon cheann de na rialacha seo beidh smachtbhannaí áirithe i gceist</li> <li>9. Má bhíonn trealamh scoile in úsáid sa bhaile beidh na freagrachtaí céanna i bhfeidhm</li> <li>10. It is a privilege for a child to be allowed use the internet.</li> <li>2. The teacher must give permission for the internet to be used.</li> <li>3. No private details may be given in any form online unless with the approval of the teacher.</li> <li>4. Children are forbidden to download any material without the teacher's permission.</li> <li>5. No personal storage, USB devices, CDs or DVDs may be used without the permission of the teacher.</li> <li>6. Children may not look at any illegal material that could damage the school's reputation.</li> <li>7. No pupil may have a mobile phone at school.</li> <li>8. Sanctions will be imposed should any of the above rules be broken.</li> <li>9. If children are using school devices at home the same rules apply.</li> <li>10. Pupils have a responsibility to behave appropriately online outside of school time also – by not sending inappropriate messages/not sending on to others inappropriate messages they may have received, through not putting inappropriate material on social media.</li> </ol>
